**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAMAR, COLORADO
AMENDING RESOLUTION No. 19-04-02 ADOPTING MODIFIED STAGE 1
MANDATORY WATER RESTRICTIONS**

Whereas, on April 22, 2019 the City Council for the City of Lamar, Colorado passed Resolution No. 19-04-02 Adopting Modified Stage 1 Mandatory Water Restrictions,

Whereas, pursuant to LMC §28-20 the Acting City Administrator, Public Works Director, Water and Wastewater Department Superintendent, and the Water Advisory Board, for the City of Lamar, Colorado have determined that the conservation of water is necessary to continue to improve water availability and water quality in Southeast Colorado,

Whereas, the Acting City Administrator, Public Works Director, Water and Wastewater Department Superintendent, and the Water Advisory Board all find it is prudent and necessary to continue to ask our citizens to use basic water conservation practices,

Whereas, the Acting City Administrator, Public Works Director, Water and Wastewater Department Superintendent, and the Water Advisory Board all find it is necessary to amend Resolution 19-04-02 in order to limit the Mandatory Water Use Restrictions to a specific time frame when the restrictions are most vital and avoid unnecessary violation when the restrictions are less vital,

Whereas, it is hereby found and determined that the meeting at which this Resolution is adopted is to be open to the public as required by law,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAMAR, COLORADO THAT:

1. Resolution 19-04-02 Paragraph 1 "Mandatory Water Use Restrictions", "**Restricted hours**" shall be eliminated and replaced as follows:

Restricted hours: From May 1st to September 30th of each year, landscape (i.e. flowers, flower beds, lawns, trees, shrubs, vegetable gardens, and plants) watering shall be permitted only before 11:00 A.M. and after 6:00 P.M.

2. All other restrictions stated in Resolution 19-04-02, issued on April 22, 2019 shall remain in full force and effect.
3. The within amended Stage 1 mandatory water restrictions are effective as of the date of adoption, by the City Council for the City of Lamar.

4. The within Stage 1 mandatory water use restrictions shall remain in effect until modified by subsequent resolution adopted by the City Council pursuant to LMC §28-20.
