Requirements to renew a contractor's license in the City of Lamar

ALL LICENSES EXPIRE ON DECEMBER 31st OF EACH YEAR

To renew a contractor's license the following must be submitted:

- 1. Proof of liability insurance for a minimum of \$100,000.
- Proof of Workman's Compensation insurance, or copy of the Opt Out documents submitted to the State of Colorado's Department of Labor & Employment as per their requirements (The insurance policy should also list the City of Lamar as a Certificate Holder for notification of any changes of policy coverage)
- 3. Payment of the respective annual fee:
 - a. *Minor Sub-contractor* Renewal \$75
 - A one (1) person company, may hire one (1) additional person
 - b. *Major Sub-contractor* Renewal \$100
 - A subcontractor person or company who hires a crew of two (2) or more persons
 - c. General Contractor Builder Renewal \$150
 - An individual or company who does construction from the ground up and/or hires a subcontractor
- 4. City of Lamar Business/Sales Tax license application and respective fee \$10.00
 - Any work performed within the City of Lamar by a third party requires having a Business License. Application attached to the back of the contractor's renewal application

*A building permit is required at all times, except when the type of work is considered to be aesthetic (e.g. painting, changing the carpet)
